Credit-On-Account Policy At V1 Flight

Customers may choose to place funds on account to simplify billing, secure discounted rates, and support training continuity. These prepaid funds are not considered gift cards or cash deposits, but are held for use exclusively on eligible services provided by V1 Flight.

Credit on Account Policy

V1 Flight customers may place funds "on account" to streamline the check-in process, reduce administrative delays, and ensure training continuity. Funds on account are not gift cards, but prepaid training balances applied directly to your flight training or charter. This system allows instructors to focus on instruction rather than collecting payment during each flight, and ensures students have sufficient funds available to meet upcoming training milestones. Customers who choose to prepay typically receive a discounted hourly rate (typically \$10/hour), which reflects a commitment to ongoing use of our training services.

Discounted Rate Conditions

Account credit is offered with the understanding that it will be used in a timely manner for services at our school. Discounts are provided only as part of this prepaid arrangement, and not

as a general entitlement. Customers who utilize the discounted rate are agreeing to apply those funds toward flight training and related services with V1 Flight without interruption or extended dormancy.

Non-Refundable After 6 Months

Unused account credit will expire 6 months after the date of last activity, with no refund due. "Activity" is defined as any flight, service, or documented scheduling attempt. This expiration period ensures operational clarity and reduces the burden of maintaining inactive balances indefinitely.

Refund Requests and Processing

Refunds are not generally permitted, but may be granted under limited circumstances at the discretion of management. If a refund is requested prior to the 6-month expiration, it will be subject to a 30-day processing period and may only be issued for funds not already associated with a discounted rate. Refunds may be adjusted to reflect the full retail rate of services already rendered. Refunds will be paid by check or ACH and may be denied if the request would effectively reverse a prior discount. There will be a 10% processing fee for refunds, if approved.

Non-Transferable and Not a Bank Account

Funds on account are non-transferable and tied to the individual or organization that made the deposit. Account credit cannot be sold, shared, or transferred to another party. This account is not a financial institution, does not bear interest, and is not protected by FDIC or similar insurance. It is intended solely for the purchase of flight training or testing services from V1 Flight.

Canceled Membership will result in no refund of credit on account.
